**Nonresident Alien Employees**  
**Venezuela**

I was a resident of Venezuela on the date of my arrival in the United States. I am not a U.S. citizen. I have not been lawfully accorded the privilege of residing permanently in the United States as an immigrant.

Any research I perform will not be undertaken primarily for the benefit of a private person or commercial enterprise of the United States.
